REF: Monthly Report for August 2013

During August 2013 the Pottstown Police Department answered 2,057 calls for service. Of these calls 2,047 occurred in the Borough.

During the month we averaged 66.35 calls per day or 33.18 calls per 12 hour shift. For the year we have answered 14,771 calls. The daily average for the year is 60.79 calls per day or 30.39 calls per 12 hour shift.

During August 2012 we answered 1,931 calls. We answered 126 more calls this month than last August. This is an increase of 6.53% from last year. For the year we have answered 302 more calls than this time in 2012. This is an increase of 2.09%.

Calls for Service - by UCR Code



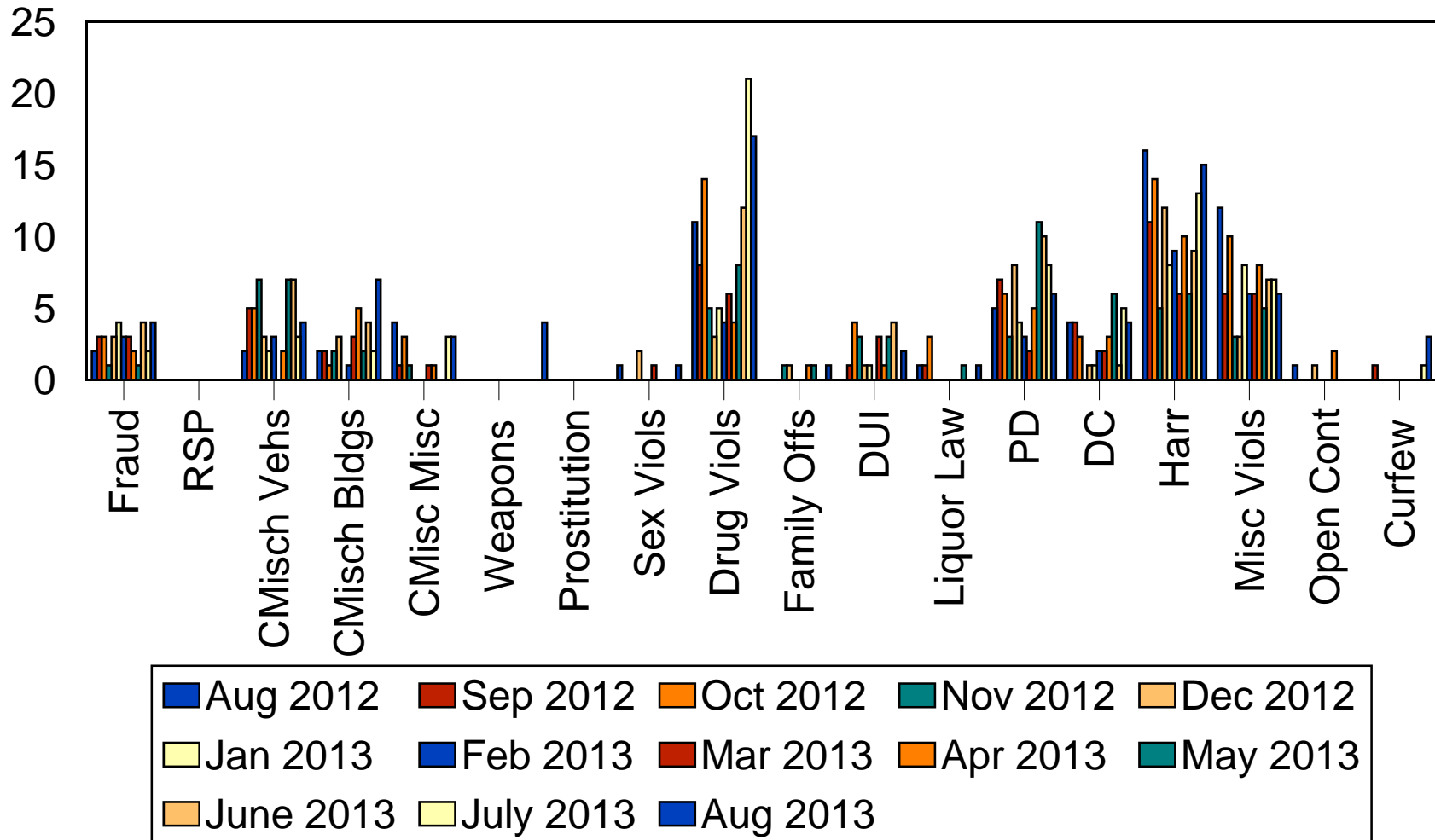
