REF: Monthly Report for July 2014

During July 2014 the Pottstown Police Department answered 2,103 calls for service. Of these calls 2,098 occurred in the Borough.

During the month we averaged 67.84 calls per day or 34.93 calls per 12 hour shift. For the year we have answered 13,084 calls. The daily average for the year is 61.72 calls per day or 30.86 calls per 12 hour shift.

During July 2013 we answered 2,082 calls. We answered 21 more calls this month than last July. This is an increase of 1.01% from last year. For the year we have answered 370 more calls than this time in 2013. This is an increase of 2.91%.

Calls for Service - by UCR Code



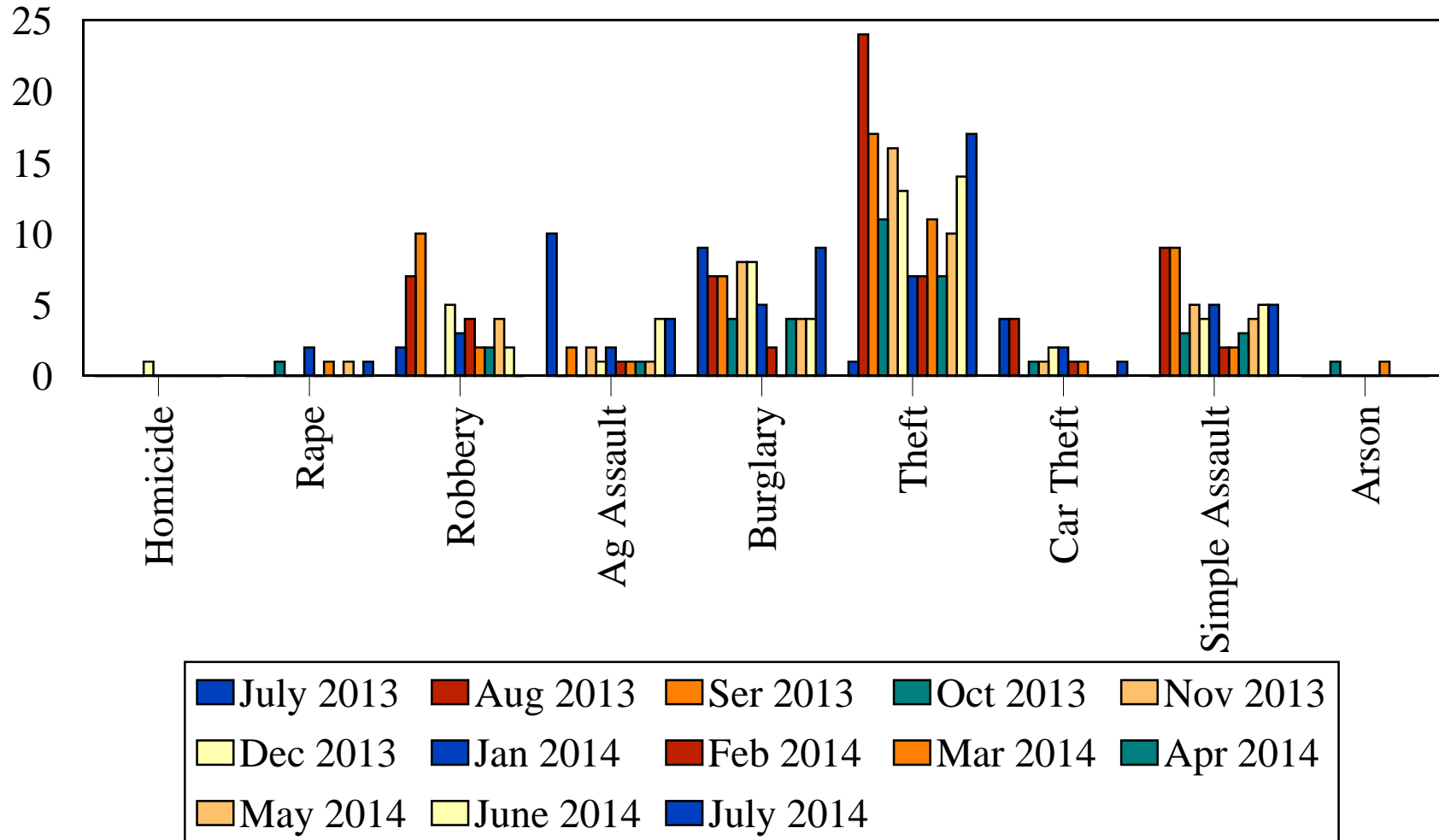

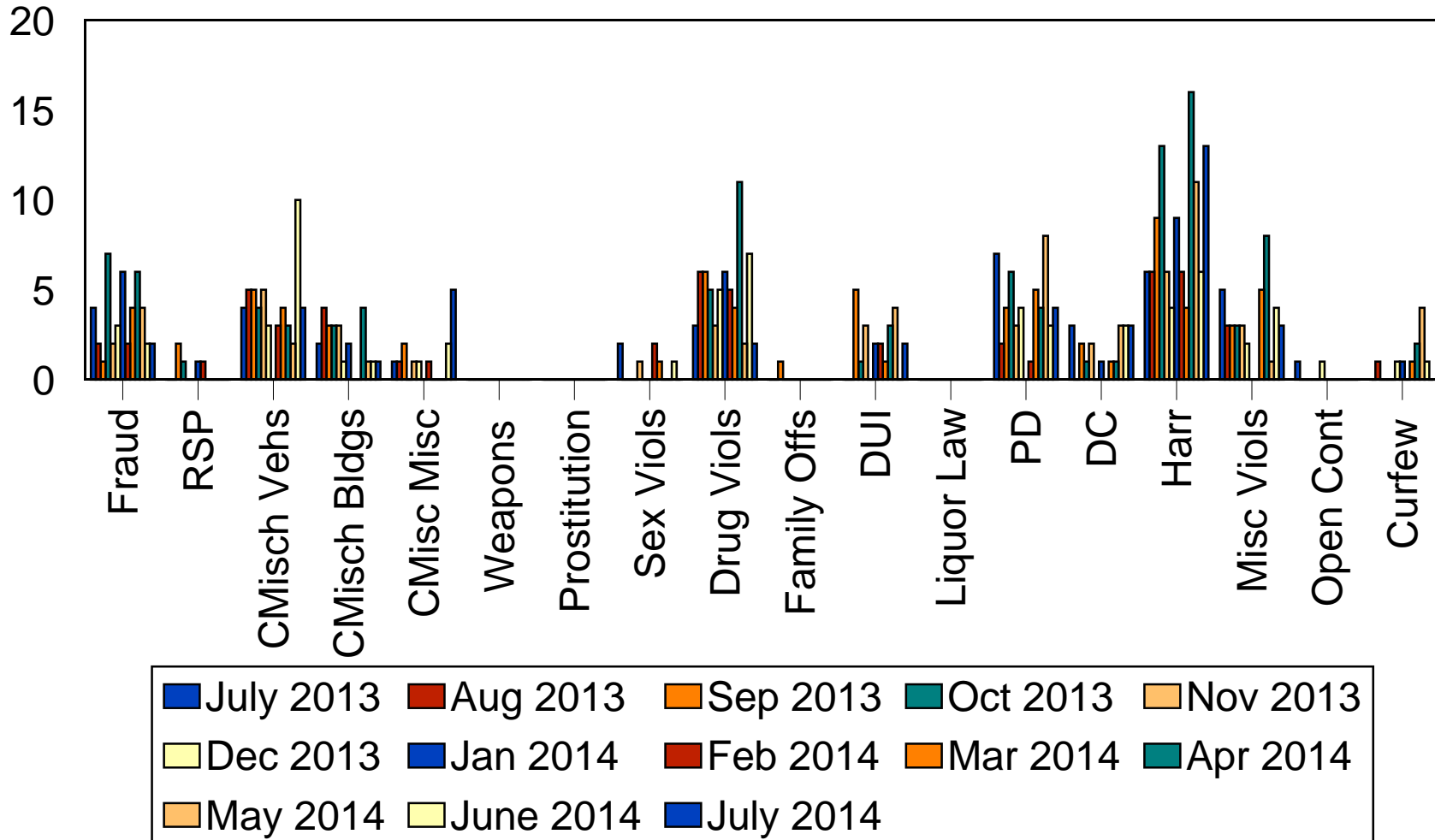

Part 1 Crimes - 12 Month Comparison



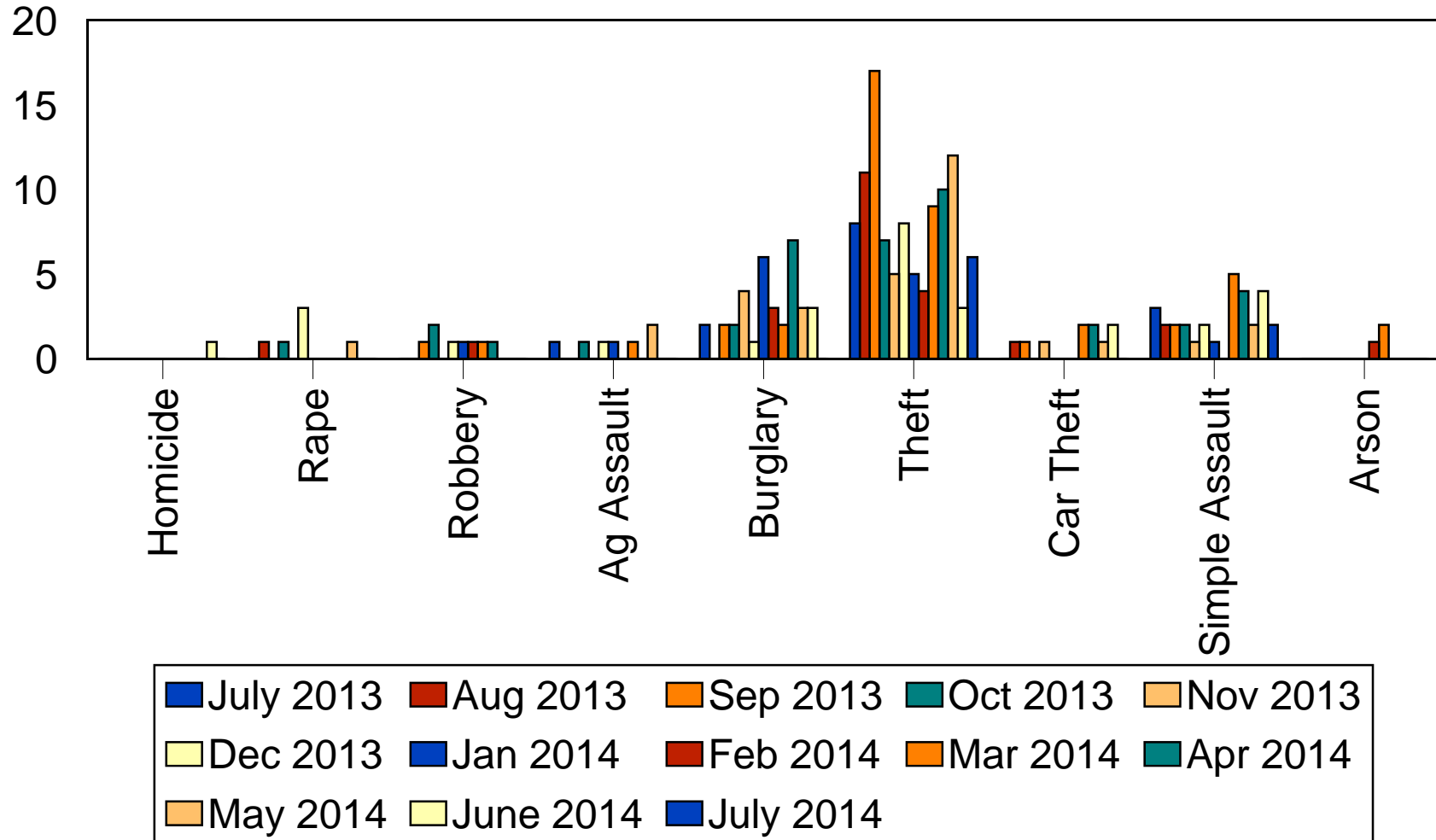
Ward 3

Part 2 Crimes - 12 Month Comparison



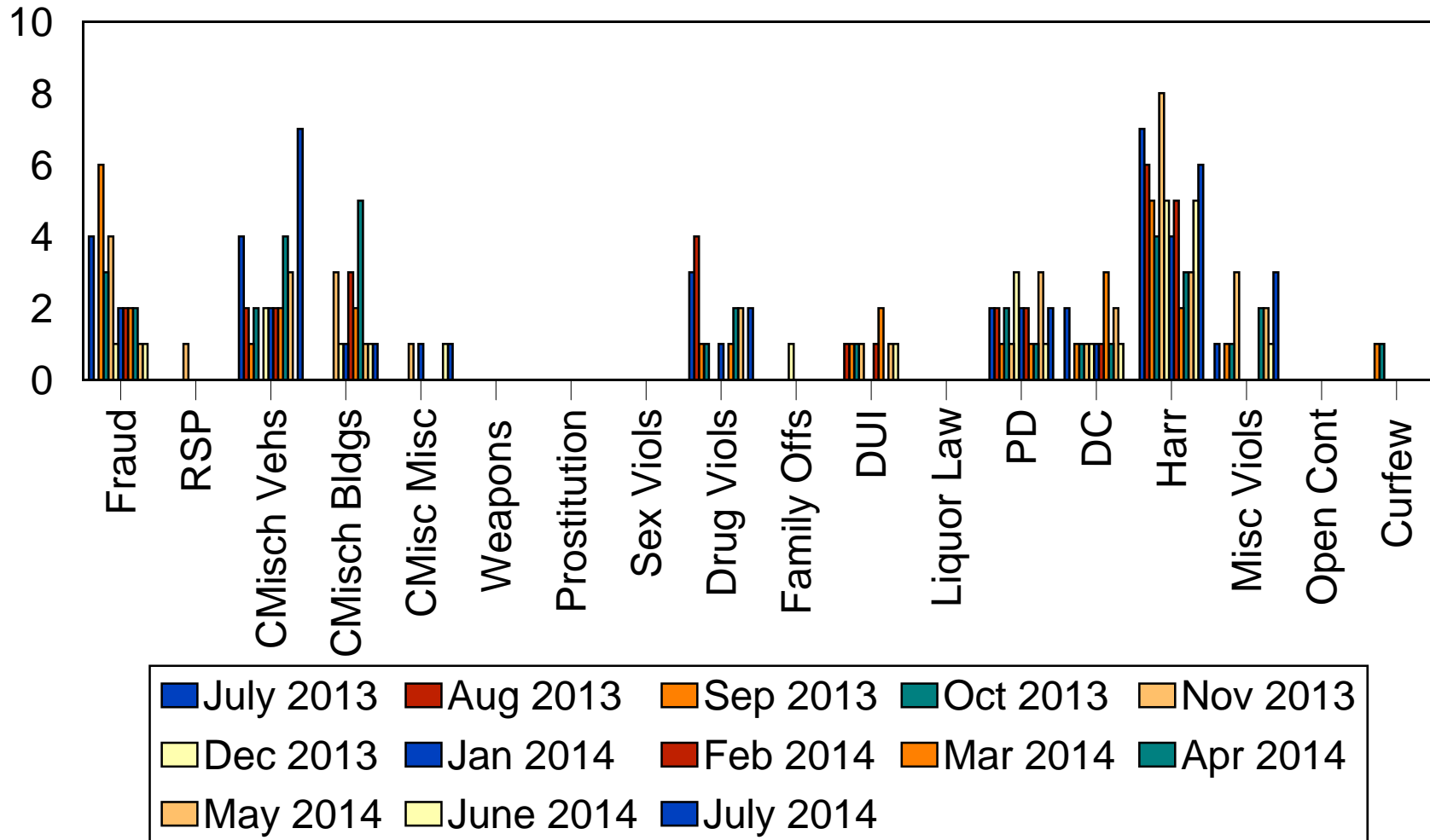

Part 1 Crimes - 12 Month Comparison



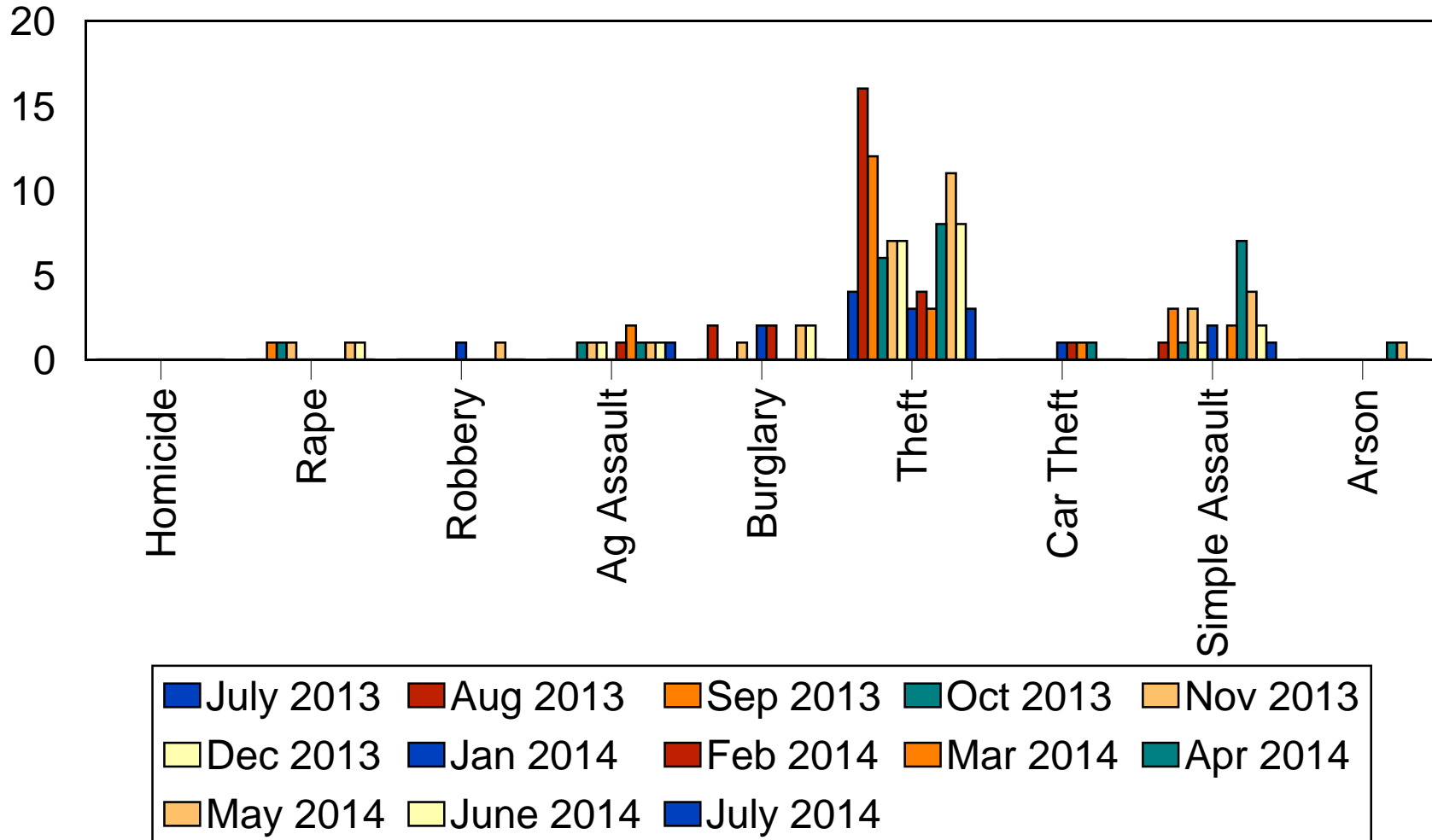
