During January 2018 the Pottstown Police Department answered 2,057 calls for service. Of these calls 2,051 occurred in the Borough.

During the month we averaged 66.35 calls per day or 33.18 calls per 12 hour shift. For the year we have answered 2,057 calls. The daily average for the year is 66.35 calls per day or 33.18 calls per 12 hour shift.

During January 2017 we answered 1,781 calls. We answered 276 more calls this month than last January. This is an increase of 15.50% from last year. For the year we have answered 276 more calls than this time in 2017. This is an increase of 15.50%.
