REF: Monthly Report for October 2012

During October 2012 the Pottstown Police Department answered 1,690 calls for service. Of these calls 1,684 occurred in the Borough.

During the month we averaged 54.52 calls per day or 27.26 calls per 12 hour shift. For the year we have answered 18,002 calls. The daily average for the year is 59.03 calls per day or 29.51 calls per 12 hour shift.

During October 2011 we answered 1,836 calls. We answered 146 fewer calls this month than last October. This is a decrease of 7.95% from last year. For the year we have answered 224 more calls than this time in 2011. This is an increase of 1.26%.

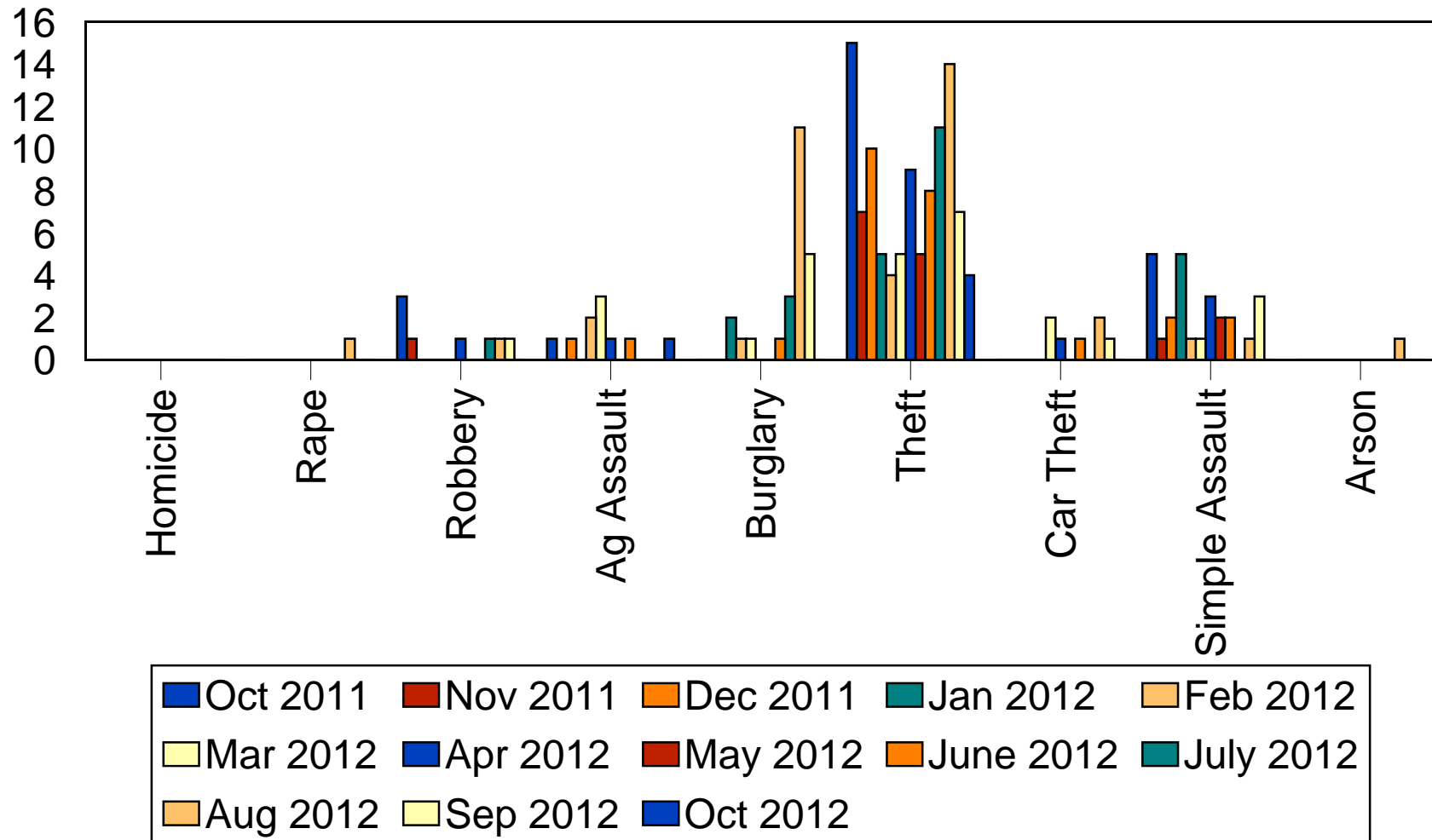
